1. Welcoming speech

5. PARAGUAY's invitation to the 2nd INCA Seminar on Dam Safety.

The delegate from Paraguay made a short summary of all the activities of his National Committee regarding the organization of the second INCA Seminar on Dam Safety at ITAIPU from the 6th to the 7th of November, and made some comments about the meeting held last April in Chicago with the World Bank to support the Seminar.

The inscriptions will be open from next July on the Web site of the Paraguayan Committee.

6. Next INCA Presidency and Vice Presidency.

The Chairman spoke about the Presidency of INCA for the next period. As is the standard alphabetical system, the next country in order after Paraguay is Peru. The Chairman asked the Peruvian delegate if it would be possible to take over the responsibility, and Mr. Miguel Suazo answered in the affirmative. The next President of INCA — who is the current Vice President — will take over the presidency next year, in New Delhi.
